4. A Springbok Award Extension must be applied for at least twenty one (21) days prior to the Scout's eighteenth birthday. Any extension application received after the twenty one-day period will not be considered.
5. The Springbok Award Extension Application details what Springbok Award requirement(s) is/are still outstanding as well as the timeline for the completion of all requirements.
6. The Springbok Award Extension Application must include a detailed explanation of the reason for the delay in the completion of the Springbok requirements as well as a full motivation and justification of the reasons for a Springbok Award Extension to be considered.
7. The Springbok Award Extension Application is then endorsed by the Troop Scouter, District Commissioner and RTC Scout Programme.
8. The Springbok Award Extension Application is forwarded to the Chair: National Scout Programme for consideration.
9. The Springbok Award Extension is then granted or rejected and the Region is informed of the National decision.
10. The Springbok Candidate is notified accordingly by the RTC Scout Programme.
