

# **Role Description: Chair: National Meerkat Programme**

#### **Role Purpose**

To lead, manage and coordinate the effective implementation of the Meerkat Programme in SCOUTS South Africa (SSA) in accordance with the Constitution, Organization Rules and Policies.

To ensure that the Meerkat Programme is regularly updated and relevant.

To represent the interests and views of the Meerkat Programme Team at Manco.

## **Functions**

- Manage implementation of the Meerkat Programme in SSA: 1.
  - Coordinate, chair and be responsible for the operation of the National Meerkat Programme a. Committee.
  - b. Monitor the progress (advancement, interest and involvement) of Meerkat Members.
  - c. Attend National and Regional Meerkat Programme events.
  - d. Attend the Manco as a Representative of the interests of the Meerkat Programme.
- 2. Manage National Meerkat events and activities:
  - a. Coordinate, monitor, attend and report on Meerkat Programme activities to the Manco.
  - b. Manage budgets (travel, material development, promotional activities and equipment) for National Meerkat Programme events.
  - c. Perform / implement any project / task / assignment, as required by the Chief Scout or Chief Commissioner.
  - d. Oversee the planning and implementation of National Meerkat events.
- Monitor training and assessment of standards: 3.
  - a. Manage the training and assessment processes for the Meerkat Advancement Programme.
  - b. Monitor and improve the standards and processes for Meerkat Challenge Awards.
  - c. Contribute to the development and provision of the Training Material for the Adult Support Team for those training modules specifically addressing the Meerkat Programme and the implementation thereof.
- Perform a support, supervisory and leadership role: 4.
